03	<u>PROVISIONAL LIST OF MEMBERS</u> The secretary general of trade organization shall display, within seven days of the announcement of election schedule, the provisional list of all members eligible to vote along with their national tax number, sales-tax-registration number, if applicable, the name and national identity card number of their representative. The list shall be displayed at- (a) notice board of the head office and regional offices of the trade organization; and (b) website of the trade organization.	22-07-2023 Saturday
04	<u>SUBMISSION OF OBJECTION ON PROVISIONAL MEMBERS LIST</u> The members who have any objection to the entries in the list of voters shall send their objections in writing to the secretary general within seven days of the issuance of the voters list.	29-07-2023 Saturday
05	<u>INTIMATION OF ACTION ON THE OBJECTION, IF ANY</u> The secretary general shall, within five days from receipt of objections under sub-rule (4), intimate action on the objections or changes, if any.	3-08-2023 Thursday
06	<u>REPRESENTATION TO ELECTION COMMISSION BY AGRIVED MEMBER</u> Any person aggrieved by decision of the secretary general may, within three days of receipt of the decision, make a representation to the Election Commission which shall decide the representation within three days .	5-08-2023 Saturday
07	<u>REPRESENTATION TO REGULATOR BY AGRIEVED MEMBER</u> Any person, aggrieved by the decision of the Election Commission or in case the Election Commission fails to decide the representation within the period provided in sub-rule (6), may, within three days of decision by the Election Commission or, as the case may be, on expiry of limitation of the Election Commission under sub-rule (6), make an appeal to the Regulator who shall decide the appeal within ten days and his decision in this regard shall be final.	8-08-2023 Tuesday 18-08-2023 Friday

10	<u>PROVISION OF FINAL LIST OF VOTERS TO CONTESTING CANDIDATE</u> Within twenty-four hours of receipt of nomination papers, a copy of the final list of voters shall be provided to each contesting candidate.	26-08-2023 Saturday
11	<u>DISPLAY OF LIST OF CANDIDATES</u> The nomination papers shall be scrutinized by the Election Commission and list of candidates shall be displayed within twenty-four hours of the last date of receipt of nomination papers.	28-08-2023 Monday
12	<u>OBJECTIONS ON NOMINATION PAPERS IF ANY</u> The objections, if any, to nomination of the candidates may be filed to the Election Commission within twenty-four hours of issuance of the list of candidates, which shall be decided by the Election Commission within two days.	29-08-2023 Tuesday
13	<u>APPEAL TO THE REGULATOR</u> Within two days of decision of the Election Commission or in case the commission fails to decide within the stipulated time provided in sub-rule (12), any candidate, aggrieved by the decision of the Election Commission or, as the case may be, on expiry of limitation of the Election Commission under sub-rule (12), may file an appeal to the Regulator, who shall decide it within seven days and his decision in this regard shall be final.	31-09-2023 Thursday 7-09-2023 Thursday
